

Please be advised that Articles 2, 6, and 7 of the “iPASS MONEY Terms and Conditions for Contracted Institutions” have been amended and will take effect on March 31, 2026.

For details regarding these amendments, please refer to the comparison table below. If your institution disagrees with these changes, please notify the Company to terminate the contract in accordance with Article 9. If no objection is raised within 7 days, the contracted institution shall be deemed to have accepted the modifications, additions, or deletions of the terms.

11. The Company may(could) require the contracted institution to undergo the necessary education and training and to cooperate in the outreach of laws and regulations.

Under the premise of complying with relevant laws and regulations and the provisions of the competent authorities, the Company may grant or directly adjust the transaction limit per transaction or the monthly payment collection limit for Type 2 contracted institution based on risk management requirements and the business status of the contracted institution; the Company shall notify the contracted institution after granting or adjusting the transaction limit or payment collection limit.

If a contracted institution is reported by judicial authorities, international credit card organizations, card-issuing institutions or other relevant agencies or units, or if the Company determines that a contracted institution is engaged in risky transactions or illegal acts, the Company may temporarily suspend the collection service without prior notice to the contracted institution, and the contracted institution shall not raise any objection.  - (1) Upon the Company's approval of the TWQR Shopping Service applied by the contracted institution, the existing electronic payment account collection service will be augmented to include QR Code payment operations provided through mobile device applications offered by cross-institutional entities.

- (2) the Company provides TWQR Shopping Service data interfacing and management systems and accepts the responsibility of collecting transaction payments on behalf of the contracted institution. The contracted institution shall proceed with the delivery of goods or provision of services to the payer based on successful transaction messages returned by the Company.
- (3) The list of cross-institutional entities applicable to TWQR Shopping Service shall be based on the information that Financial Information Service Co., Ltd notified the Company.
- (4) The contracted institution should display the trademark or identifier of the TWQR Shopping Service provided by the Company. If the aforementioned trademark or identifier needs to be used for purposes other than providing the TWQR Service, the contracted institution must obtain prior permission from the owner of the trademark or identifier. Such permission does not constitute any form of rights or obligation transfer.
- (5) Any disputes over refunds between the contracted institution and the payor involving the TWQR Shopping Service should be handled through communication between the contracted institution and the payer. However, the Company may provide necessary assistance.
- (6) The contracted institution agrees that the Company may, as required for the operation of the TWQR Shopping Service,

Such permission does not constitute any form of rights or obligation transfer.
- (5) Any disputes over refunds between the contracted institution and the payer involving the TWQR Shopping Service should be handled through communication between the contracted institution and the payer. However, the Company may provide necessary assistance.
- (6) The contracted institution agrees that the Company may, as required for the operation of the TWQR Shopping Service, submit or register information such as the store name, tax

If confirmed by the Company as true, it shall be deemed default and the Company may suspend the transaction or directly terminate the Agreement.
8. If a contracted institution provides users with credit card payment linked to an electronic payment account, the contracted institution shall comply with the following matters:
 - (1) The contracted institution must pay attention to whether there are any abnormal card swiping situations with the users it transacts with. If any suspicious credit card transactions are found, or if the credit cards used by the transacting users include but are not limited to likely forgeries, reported lost cards, or if the cardholder's transaction behavior is suspicious, the contracted institution shall notify the Company to assist in verification with the cooperative financial institution and cooperate in necessary processing.
 - (2) Without the prior written consent of the Company, the

5. The contracted institution shall not make advance payments for relevant fees on behalf of the user, and request the Company to make the payment later on.

6. Unless a contracted institution has a due reason and both parties agree to it, contracted institution shall not restrict or reject user's use of the electronic payment account for payment or participation in various kinds of special offers.
7. Unless the contracted institution has a due reason and both parties agree to it, the contracted institution shall not pass on the service fee and other expenses required by the terms and conditions to the user, or increase the price for other reasons. If confirmed by the Company as true, it shall be deemed default and the Company may suspend the transaction or directly terminate the Agreement.

contracted institution shall not install any other hardware or software programs that capture or retain cardholder data. In case of violation, the Company may suspend or terminate the contracted institution's use of the credit card payment agency collection and payment service. If damage is caused, the contracted institution shall be fully liable for damages and losses.

- (3) When a user uses a credit card to pay for a transaction, the entire transaction must obtain authorization and request payment at one time. The contracted institution shall not split one transaction into two or more amounts (i.e., breaking up the whole into parts) for separate transactions to re-obtain individual transaction authorization numbers or engage in any other disguised financing arrangements.
- (4) When a contracted institution uses the credit card payment agency collection and payment service for online transactions with a payor user, the user is exempt from signing the sales slip and swiping the card. The contracted institution must retain evidence of online transactions that can be provided to the Company at any time. If the Company notifies the contracted institution that the relevant credit card payment has failed, the contracted institution shall not deliver goods or continue to provide services or labor. Contracted institutions shall not allow institutions that do not provide goods or services, such as financial financing companies, to conduct transactions

through the credit card payment agency collection and payment service.

(5) If the contracted institution falls under any of the following circumstances, the Company has no obligation to pay for the credit card agency collection and payment transaction. If the Company has already made the payment, the contracted institution shall be responsible for returning it. The Company may also directly deduct and offset it from any requested payment amount or payable amount to be paid to the contracted institution or from the balance in the contracted institution's electronic payment account. The contracted institution shall still be liable for compensation for any damages and all related expenses derived therefrom:

- A. The contracted institution fails to process the account in accordance with the specifications of this Article.
- B. Credit card agency collection and payment transactions conducted not through an exclusive store code assigned by the Company.
- C. Transactions obtained not through the Company's credit card agency collection and payment service.
- D. Transactions without actual purchase of goods or services, including but not limited to using a credit card for cash advances.
- E. The contracted institution accepts credit card

transactions arising from business items that are not legally registered, or illegal transactions between both parties to the transaction, including but not limited to cash lending transactions; however, if the contracted institution provides proof that the credit card transaction did not arise from a business item that is not legally registered, and the Company and the cooperative bank confirm that the fund is no longer withheld by judicial authorities or rejected by other card-issuing institutions, the Company shall return the fund to the contracted institution.

F. The Company receives a notification of refusal to pay the transaction amount from a credit card issuing institution, an acquiring institution, or any domestic or foreign clearing institution.

G. The contracted institution is determined by the Company, judicial and related authorities, international credit card organizations, card-issuing institutions, or other acquiring institutions to be inconsistent with the credit card transaction rules and customs established by international credit card organizations.

H. The user has not received the goods or services, or there are disputes, payment refusals, or claims regarding each of those goods and services.

- (10) If the contracted institution is reported as a risk store by an acquiring institution, the Company may terminate the contracted institution's provision of this payment method at any time, and the contracted institution shall have no objections or claim any rights.
- (11) The contracted institution shall not lend, assign, or provide the store code of the credit card payment agency collection and payment service provided by the Company to others, or borrow a contracted institution code from others.
- (12) The contracted institution shall not damage the credit card supplies and related hardware and software equipment (including card readers) provided by the Company, steal transaction data, or modify relevant programs without authorization.
- (13) When the annual transaction amount accepted by the contracted institution via credit card exceeds a certain requested payment amount stipulated by international credit card organizations, the contracted institution shall sign a contracted institution contract with an acquiring institution starting from the following year.
- (14) The contracted institution acknowledges that its services must not infringe upon the rights and interests of users. The contracted institution shall be solely liable for any such infringement. If a user pays via a credit card linked

to an electronic payment account and then claims refusal of payment or other disputed transactions through the card-issuing institution, the Company will assist the contracted institution and the user in handling the disputed amounts in accordance with the relevant laws and regulations of the competent authority regarding the "Credit Card Consumption Dispute Account Processing Mechanism."

- (15) The contracted institution shall handle the services related to this contract in accordance with the relevant laws and regulations of the Regulations Governing Institutions Engaging in Credit Card Business, self-regulatory norms, and relevant regulations of international credit card organizations, and agrees to cooperate with the Company's instructions and requirements made to follow the "Self-Regulatory Norms for Credit Card Acquiring Institutions Signing 'Agency Collection and Payment Service Platform Operators' as Contracted Institution" and relevant interpretative letters.
- (16) The contracted institution must pay attention to whether there are any abnormal transactions with the users it transacts with. If any suspicious credit card transactions are found, or if the credit cards used by the transacting users include but are not limited to likely forgeries, reported lost cards, or if the cardholder's transaction behavior is suspicious, the contracted institution shall
